HOW IT WORKS: Complete FEMA online courses and convert them to college credits at Frederick Community College (FCC). In the chart below, Column A shows you the FCC course names and Column B shows you the corresponding FEMA online course(s) that you will complete to meet the FCC course requirements and qualify for college credit. Some courses can be converted to college credit alone while others require you to complete 2, 3, 4+ FEMA courses to earn one or three college credits. Use this FCC Course List to determine which courses you want to complete to convert to credit. Complete the courses and final exams (links on chart) on the FEMA website. After you have completed the coursework needed to meet your college credit goals, you will complete and submit the Credit Conversion Request Form to FCC which is found at Step 3 on <https://macem.org/independent-study-credit-conversion-programs.aspx/>.
